Bus Brinig described the structure of a corporation and laid out the basics for our organization. It was decided that Mid-Atlantic Vintage Trials Inc. would be the name of the organization that replaces Roger Annable's "Mid-Atlantic Trials LLC."

Officers were selected from volunteers as follows:

President: Greg Myers - Duties include schedule creation, maintaining membership lists, general oversight.

Vice President: Sonny Deitz - Duties include assisting and supporting the president in all matters

Secretary: Peter Wilmon - Duties include recording minutes of meetings, keeping records.

Treasurer: Josh Packard - Duties include handling all business transactions and providing financial oversight to the organization

Score Master: Chris Hoffmeister - Duties include recording event scores, individual rider statistics and creating related documents

Insurance Director: Jeff Hightman - Duties include handling all insurance needs

Awards Director: Krista Beljan- Duties include creation / acquisition of year end awards

Web Master(s): Roger Annable and Ray Donet Jr. - Duties include posting event schedules, flyers, results and standings, maintaining the Facebook webpage.

Safety Director: John Stark – Duties include instructing event organizers and Trialsmasters on safe practices. General overseeing the safe operation of events.

Club representatives (1 per club)

Much discussion was held related to membership, finances, scoring and insurance. Resolved was:

1. That former lifetime membership in Mid-Atlantic Trials LLC would no longer be in effect. We are a new organization therefore need not honor the past contracts. Furthermore to continue lifetime membership would not be financially viable.
2. There will be no change in membership cost. Members will pay \$30.00 annually. Non-members will pay an additional \$10.00 at sign-up for each time they compete. The non-member fee is to be sent to the Mid-Atlantic Vintage Trials Inc. treasurer after each event. The membership fees pay for year-end awards and cover operating costs of the organization.
3. Championship year end awards are only available to members.
4. A new membership application will be developed. The final version will be approved by the organization before being put in effect.
5. To assure insurance compliance minor release forms will need to be submitted at each event. These will be made available on the web site for advanced access by parent / guardian. Sorry, no yearly submitted minor release form.
6. Insurance will most likely change from the past due to the unavailability of insurance from National Motorsports. Currently used release forms will most likely need to be replaced. Much work will be done to secure insurance for our events.

Discussion was held regarding the gate trial format. Resolved was that Roger Annable will be hosting a Gate Trial at his residence which will be independent of the Mid-Atlantic Vintage Trials Inc. organization.
